## 2023 WEATHER GUARD® Speedway Motorsports Giveaway Official Rules

- 1. CONTEST PERIOD: Contest ("Giveaway") begins at 8:00 AM Central Standard Time ("CT") June 1, 2023 and ends 11:59 PM CT on August 31, 2023. ("Giveaway Period"). Werner Co.'s (also referred to as the "Administrator" or "Sponsor") computer is the official timekeeping device for the Giveaway.
