

HAPPY CAMPER SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. OPEN TO LEGAL RESIDENTS OF THE 48 CONTIGUOUS UNITED STATES AND WASHINGTON, D.C. VOID IN ALAKSA, HAWAII, FLORIDA, LOUISIANA, NEW YORK, RHODE ISLAND, PUERTO RICO AND ALL OTHER U.S. TERRITORIES, ELSEWHERE OUTSIDE THE UNITED STATES, AND WHERE RESTRICED OR PROHIBITED BY LAW.

1. SWEEPSTAKES DESCRIPTION AND ELIGIBILITY: The Happy Camper Sweepstakes (the “Sweepstakes”) is sponsored by Speedway GLOBE, LLC (the “Sponsor”). The Sweepstakes begins on, February 14, 2025, at 9:00am Eastern Standard Time (EST) and ends Sunday, August 31, 2025, at 11:59pm Eastern Daylight Time (EDT) (the “Sweepstakes Entry Period”). The Sweepstakes is open to all legal residents of the forty-eight (48) contiguous United States and the District of Columbia (excluding Alaska, Florida, Hawaii, Louisiana, New York, Rhode Island and Puerto Rico), who are (21) years of age or and have a valid driver’s license in their state of residence the time of Entry, as defined below. Employees, temporary employees, independent contractors, interns, and their immediate families (spouses and parents, siblings and children and their spouses) or members of the same household (whether related or not) of Sponsor, Speedway Motorsports, LLC, Sonic Automotive, Inc., EchoPark Automotive, Inc. (EchoPark), Thor Industries, Inc. (Thor), NASCAR, LLC, and each of their respective affiliates, subsidiaries or parent companies, their respective employees, shareholders, officers, directors, agents, members, successors, assigns, each of their respective marketing agencies and any other companies involved with the design, production, execution or distribution of this Sweepstakes (the “Sweepstakes Entities”) are NOT eligible to enter. Void where prohibited by law.

2. HOW TO ENTER: There are two ways to enter the Sweepstakes during the Sweepstakes Entry Period.

(a) Internet. Visit <https://www.speedwaymotorsports.com/happycamper/> (the “Sweepstakes Site”). Entrants must complete the required fields with their First Name, Last Name, Email, Phone Number, and Zip Code and answer the following questions: (1) Are you in the market for a used car?, (2) Year, make and model of current car, (3) Do you currently own an RV?, and (4) Are you interested in purchasing an RV? All fields must be completed to be deemed a valid entry.

(b) QR Code. Use your smart phone or other web-enabled device with data plan to scan the Sweepstakes quick response (“QR”) code featured on signs or promotional materials in the Fan Zone at participating speedways during NASCAR event weekends: Atlanta Motor Speedway (Feb 22 and 23), Circuit of the Americas (March 1 and 2), Las Vegas Motor Speedway (March 14 -16), Texas Motor Speedway (May 2 – 4), Charlotte Motor Speedway (May 23-25), Nashville Superspeedway (May 30 – June 1), Atlanta Motor Speedway (June 27 and 28), Sonoma Raceway (July 12 and 13).

You will be directed to a mobile Web page at <https://www.speedwaymotorsports.com/happycamper/> (also a “Sweepstakes Site”) where you must complete the required fields with their First Name, Last Name, Email, Phone Number, and Zip Code and answer the following questions: (1) Are you in the market for a used car?, (2) Year, make and model of current car, (3) Do you currently own an RV?, and (4) Are you interested in purchasing an RV? All fields must be completed to be deemed a valid entry.

Proof of scanning QR codes does not constitute proof of completion or submission of an entry. The participating speedways are subject to change.

To scan a QR code, participants must have a smart phone or other web-enabled device with a camera feature and/or QR scanner application and may incur message or data charges from their wireless service provider for

each message sent and received. If you do not have a QR reader already installed on your phone, type 'QR reader' in your mobile device's application store search field to find available QR readers for your smart phone or other web-enabled device. You will receive a response which will contain a link to download a QR reader for your specific device. Check with your wireless service provider for details on these and other applicable charges. Participants are solely responsible for any such wireless charges. Not all wireless carriers participate.

(c) For all Entries. All entries become the exclusive property of the Sponsor and will not be (returned or) acknowledged. By submitting an entry into the Sweepstakes, entrant unconditionally accepts and agrees to comply with and abide by the Official Rules and all decisions of Sponsor, whose decisions will be final in all regards. Sponsor reserves the right to modify or update these Official Rules without notice at any time during the Sweepstakes Entry Period as may be deemed necessary or required, as determined by Sponsor's sole discretion. This Sweepstakes is subject to all applicable federal, state and local laws.

Eligible participants may enter a maximum of one (1) time during the Sweepstakes Entry Period, regardless of the number of email addresses or phone numbers the Entrant may have. Duplicate and electronically reproduced entries will be disregarded. Sponsor reserves the right to disqualify any participant from the Sweepstakes at any time if Sponsor determines that such entrant has entered the Sweepstakes using automated means. Sponsor is not responsible for illegible, incomplete, altered, lost, late, or misdirected entries, or for failure to receive any entries due to transmission failure or technical failure of any kind, including, without limitation, malfunctioning of any mobile app, network, hardware or software, whether originating with participant or Sponsor. In the event of a dispute, all entries will be deemed to have been submitted by the owner of the electronic account listed in the entry. For these purposes, an account holder shall mean the natural person assigned to such electronic account by the Internet access provider, online service provider or other organization responsible for assigning such electronic account. Any questions regarding the owner of an account shall be determined by Sponsor in its sole discretion.

3. GRAND PRIZE DRAWING AND WINNER NOTIFICATION: All eligible entries received during the Sweepstakes Entry Period, will be entered into a Grand Prize drawing conducted by Sponsor on Monday, **September 1, 2025**. The potential Grand Prize Winner will be notified by phone call, text message and/or email (provided on the entry form) no later than **24 hours** after the end of the Sweepstakes Entry Period.

If potential Grand Prize Winner fails to response to Sponsor within **48 hours** of notification, potential winner shall forfeit Grand Prize and Sponsor may select an alternate potential Grand Prize Winner from the remaining eligible entries. Potential Grand Prize Winner will be subject to verification of eligibility and compliance with Official Rules. The Grand Prize Winner will be required to sign and notarize an Affidavit of Eligibility and Liability/ Publicity Release, then return it within **48 hours of notification**. Noncompliance within specified time period or return of the Grand Prize notification as undeliverable or a determination that any selected participant is ineligible will result in disqualification of that selected participant. If the potential Grand Prize Winner declines the prize or fails to complete and return the required documents to the Sponsor, then the potential alternate Grand Prize Winner will be contacted by the Sponsor. - 2025 Bank of America ROVAL 500 trip prize package with an approximate retail value of \$5,200 (“**Trip Prize Package**”), as further described below:
 - Roundtrip economy/coach airfare, within the contiguous United States to Charlotte Douglas International in Charlotte, North Carolina, for winner and guest (October 3 –6, 2025)
 - One (1) 3-night stay valid only (October 3 – 6, 2025) at a local Charlotte hotel
 - Two (2) tickets to the NASCAR Xfinity series race on October 4, 2025

The approximate retail value of the Grand Prize is estimated between \$83,613 and \$112,100 and is dependent on the type of RV selected by winner. The difference in value of Prize as stated herein and value at the time of Prize notification/award, if any, will not be awarded.

6. PRIZE CONDITIONS: The Grand Prize is non-transferable and no substitution or cash equivalent is allowed except as provided herein at the Sponsor's sole discretion, or as otherwise stated in these Official Rules. (b) **RV Prize Conditions.** The exact, year, make, model and trim level of the RV will be determined based on availability at time of award, and Thor reserves the right to provide a RV of comparable value. Winner must be a U.S. licensed driver and will be required to provide proof of valid U.S. driver's license and legally required insurance at time of vehicle delivery (or an alternative winner shall be selected if applicable and the original Winner's rights to the RV Prize shall be automatically forfeited). Sponsor is responsible for all costs associated with the shipping of the RV to Winner's home, the applicable federal, state and local sales taxes due on the RV Prize ARV prior to delivery to Winner and Winner's receipt and acceptance of the RV Prize. Winner is responsible for RV registration, license, title and insurance fees and other fees associated with RV Prize as well as any taxes that may be due after Winner takes delivery of the RV Prize. The Sweepstakes Entities shall not have any responsibility or liability whatsoever for any property loss, damage, personal injury, or death, in connection with the RV Prize provided pursuant to the Sweepstakes and/or any person's participation in the Sweepstakes; provided, however, that the RV manufacturer shall be solely responsible for any express-written limited warranties specifically set forth in the applicable warranty. Sponsor and Thor shall not be responsible for delays in delivery of the RV Prize, and delivery is subject to availability. Sponsor and Thor, however, shall use all reasonable efforts, subject to availability, to deliver the RV Prize within one hundred eighty (180) days of completion of verification process. The Winner shall bear all risk of loss or damage to the RV Prize after it has been delivered to the specified delivery site. RV Prize is non-transferable and no substitution or cash equivalent is allowed except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute the RV Prize for one of comparable or greater value, at its sole discretion. Winner is responsible for costs and fees associated with RV Prize receipt and/or use not specified herein as being awarded.

(c) **Trip Prize Conditions.** Winner's guest (who will participate in the Trip Prize Package with Winner) must be at least 21 years of age in order to participate. Seat and parking locations at the event shall be determined in the sole discretion of Sponsor. The event and event dates and times are determined in the sole discretion of NASCAR, Sponsor, or prize provider (as the case maybe), and may be subject to change. The terms and conditions of the prize awarded will govern in the event an event is not conducted due to weather conditions, an act of God, and an act of terrorism, civil disturbance or any other reason.

Winner and his/her guest agree to comply with all applicable regulations in connection with the Prize. Sponsor reserves the right to remove or to deny entry to anyone who engages in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the event. The Sweepstakes Entities will not be responsible for weather conditions, Acts of God, acts of terrorism, civil disturbances, work stoppage or any other natural disaster outside their control that may cause the cancellation or postponement of any event. Flight schedules are subject to change without notice. Sponsor and Sweepstakes Entities

will not be liable for any missed opportunities or expenses incurred as a consequence of flight cancellation/delay or ground transportation delay. Sponsor will not sell, rent, transfer or otherwise disclose Entrant's personally identifiable information to any third party other than as permitted by these Official Rules or privacy policy.
